## **ARTICLES OF INCORPORATION**

These Articles of Incorporation (the "Agreement") are made and effective October 1st. 2011.

BY Upturn Crypto LLC (the "Incorporator"), a corporation organized and existing under the laws of the [State/Province] of Melbourne, with its head office located at:

AND The Kestrian Group Limited (the "Incorporator"), a corporation organized and existing under the laws of the [State/Province] of Melbourne, with its head office located at:

33, Draper Rd, Okshaw, Melbourne VIC 3004, Australia

#### 1. ARTICLES OF INCORPORATION OF BRIDGESTONE-COIN

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the [State/Province] of Melbourne.

#### 2. Name

The name of the corporation shall be: Upturn Crypto LLC alias UCI LLC

#### 3. NATURE OF BUSINESS

This corporation may engage in or transact any and all lawful activities or business permitted under the laws of Australia, the State of Melbourne, or any other state, county, territory or nation.

#### 4. CAPITAL STOCK

Neither any amendment nor repeal of this Article VII, nor the adoption of any provision of this Certificate of Incorporation inconsistent with this Article VII, shall eliminate, reduce or otherwise adversely affect any limitation on the personal liability of a director of the corporation existing at the time of such amendment, repeal or adoption of such an inconsistent provision.
